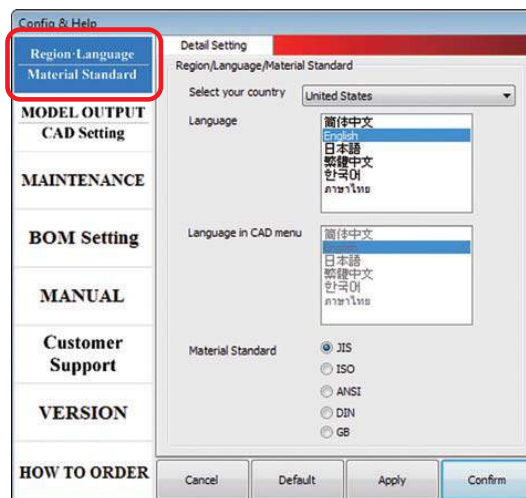
D1. Selecting the language

Available in six languages; Simplified Chinese, English, Japanese, Traditional Chinese, Korean, and Thai.

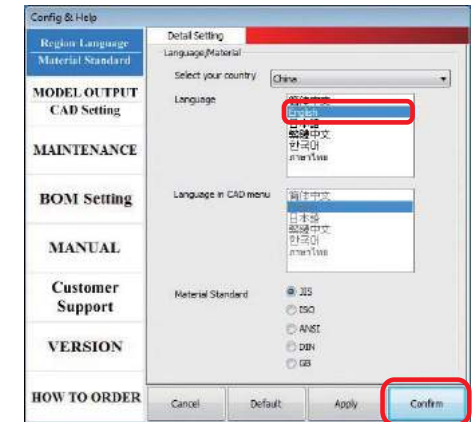
1 Open the Help.



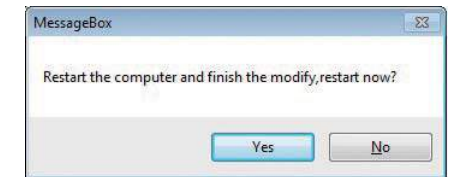
2 From the menu in the left, select [Region Language].

4 Please save the other files being opened before you restart the computer to allow the setting to take effect.



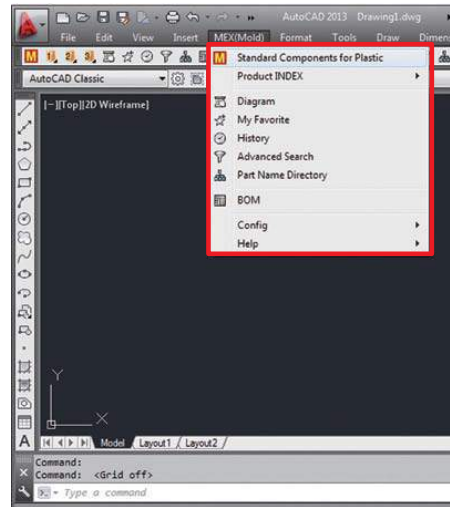
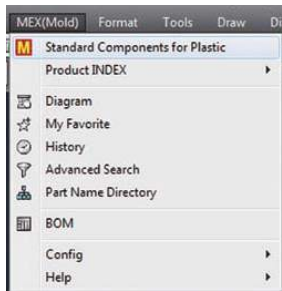

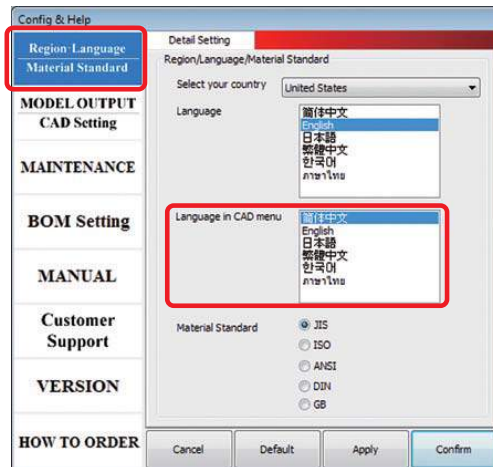
D2. Language setting of Mold EX-Press drop-down menu in CAD

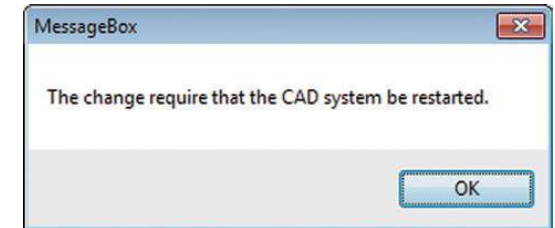
1 Drop-down menu is displayed in English.



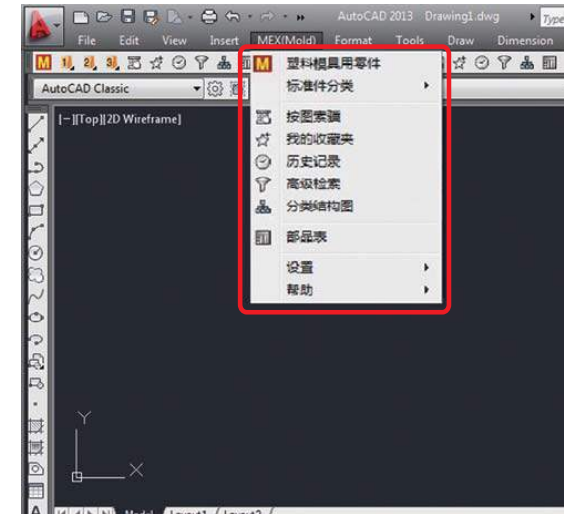

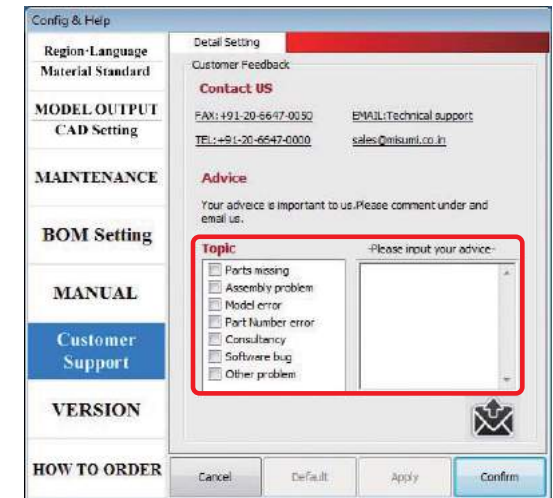

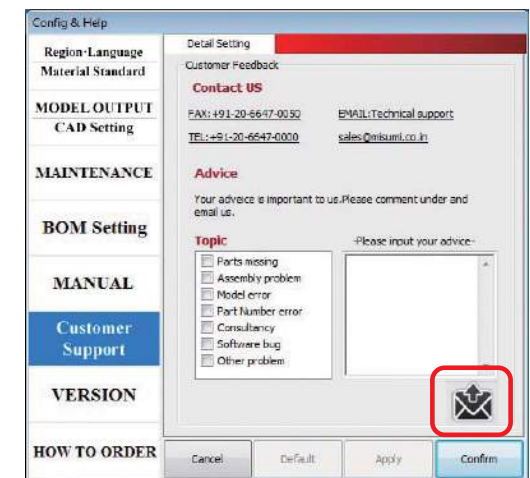

Even during the effective term of THIS LICENSE AGREEMENT, OUR COMPANY may abolish the standards, terminate or suspend sales, or change the specification of our products provided with information in THIS SOFTWARE, without advance notice.

Article 9 – Suspension and Return, etc.
